Public procurement in Kenya faces many challenges today and the procurement professional as employees of the government has borne the brunt of these challenges. The professional faces a very competitive tenderes who are ready to do anything they can to win bids while the Public Procurement and Asset Disposal (PPAD) Act 2015 must be adhered to the letter.
