Question TWO

- (i) You have been hired to work for Mombasa County TV, a local television station in Mombasa, giving examples, examine how you would write a television news script. (**10 Marks**)
- (ii) The following facts from a press conference addressed by Mombasa Senator Hassan Omar, write a sample news story using. (10 Marks)
 - Mombasa town is in a crisis because many of you decided to fold their arms and watch as things deteriorated. As we usher the new year, there is need to stand up and be counted.

- Following the visitors that we have had in the last one month, all of them point to the fact that the county of Mombasa is extremely filth. I want to link to you what the filth of corruption or the nexus of the filth of corruption can do to service delivery. Why it is filthy is because somebody is stealing.
- So I would like that we prosecute the filthy and the procurement department of the county government of Mombasa. Over the last four to five weeks, our visitors have complained about all sorts of filth.
- Governor Hassan Joho's administration singled-sourced a garbage disposal company, in violation the Public Procurement and Asset Disposal Act.
- Mombasa county squandered Sh1 billion through irregular allocation of a contract for garbage collection, Senator Hassan Omar said yesterday.
- The directors of the company, who have for the last four years been paid Sh300 million annually for garbage collection, are close associates and cronies of Joho.
- Part of the "irregular award" and the cost were mentioned in the Auditor General's Report 2014-15 as cash that could not be accounted for, he said.
- There is an attempt by the county to undermine the EACC investigations.
- Some of these documents were shared with them [EACC] voluntary and they raided and found the documents are incontrovertible evidence. Why are persons not being prosecuted?
- Omar demanded EACC forward the file to the Director of Public Prosecutions. The EACC should recover the money from the governor and all other beneficiaries.
