## **SITUATION**

The Governor of Central Bank of Kenya, Dr Patrick Njoroge throws light on why the banking watchdog intervened in four banks on Monday – with specific reference to Jamiibora Bank, Wakulima Bank and Bank, Wema Bank, and Unity Bank.

Responding to a question and answer session during a joint news conference with the Parliamentary Select committee investigating banking crisis in Kenya, Dr Njoroge explained that the situation in Jamiibora Bank was very severe and compounded by its acquisition by Wakulima Bank.

In his words, "the decision of Wakulima Bank to acquire JamiiBora Bank with 62 billion Kenya Shillings was a governance issue in addition to other things that we do not want to say now but which you will know later."

The CBK on Friday sacked the Managing Directors of Wakulima Bank, JamiiBora Bank and Wema Bank as well as their executive directors after they failed to provide a comprehensive report on the status of their banks as demanded by CBK.
