Question ONE

TENGEZA LIMITED

Tengeza Limited is a leading manufacturer of copper, iron and brass fitting in the country. An assessment of its procurement activities by the auditor has shown a score of 40% in terms of its efficiency and potential to comply with procurement regulations. Its procurement function is disjointed and thus there are a few fraudulent cases being reported as well as challenges in procuring commodities (copper, iron and brass) for the firm.

The management has proposed that the procurement function should be decentralized to overcome these problems. The firm has also had challenges in finding suppliers for its routine purchases and thus spending too much time and funds leading to unnecessary losses. The auditor has advised the management to do an analysis of its prices to ensure effective costing of materials.

- b) Appraise five benefits that would accrue to Tengeza Ltd by decentralizing its procurement function (10 Marks)
